"Let's Talk: Share Ideas & Score the Newest Smartphone!" Campaign Terms and Conditions

INTRODUCTION

Lendermarket offers investors the opportunity to win rewards (Samsung Galaxy S24 Plus 5G 256GB or iPhone 16 Pro 5G 128GB black) by sharing their feedback and depositing and investing through the Lendermarket platform. By participating in this lottery, users agree to these Terms and Conditions as outlined herein. The terms used herein shall have the same meaning as described in the Rules of the Platform unless the context otherwise requires or are defined differently in the present Terms and Conditions.

PERIODS OF THE LOTTERY

- 1. **Campaign Period:** From 31st October 2024 at 00:01 GMT+1 until 19th November 2024 at 23:59 GMT+1 (both inclusive).
- 2. **Depositing Period:** From 31st October 2024 at 00:01 GMT+1 until 14th November 2024 at 23:59 GMT+1 (both inclusive).
- 3. **New Investments Period:** From 31st October 2024 at 00:01 GMT+1 until 14th November 2024 at 23:59 GMT+1 (both inclusive).
- 4. **No Withdrawal Period:** Users must not withdraw any funds from their investor accounts from 31st October 2024 at 00:01 GMT+1 until 14th November 2024 at 23:59 GMT+1 (both inclusive).
- 5. Winners Announcement Day: The winners will be announced on 19th November 2024.

ELIGIBILITY CRITERIA

A user qualifies for the lottery if all the following conditions are satisfied:

- 1. **Investor Status:** The user is either a new or existing investor.
- 2. **Feedback Submission:** The investor must share feedback via a Google form.
- 3. **New Investments:** The user has made new investments during the New Investments Period from newly deposited funds during the Depositing Period ("Participations") in any of the Listed Loan(s) on the Lendermarket platform.
- 4. **Minimum Participation:** The minimum Participation during the New Investments Period is €500 (five hundred euros) and can be made up of single or multiple investments.
- 5. **No Withdrawals:** The user has not withdrawn any funds from their investor account during the No Withdrawal Period.
- 6. **Interview Requirement:** To receive the prize, the winner must participate in a short interview (mandatory, 5–7 questions; written form), which may be published on Lendermarket communication channels.

- 3. **Winner Selection:** One winner shall be randomly selected from each of the specified regions, with each winner entitled to receive one mobile phone as a prize.
- 4. **Prize Choice:** The winner can choose either a Samsung Galaxy S24 Plus 5G 256GB or an iPhone 16 Pro 5G 128GB black. They cannot choose both.
- 5. **Prize Delivery:** Lendermarket will get into contact with the winner per 3 w.d. after the winner's announcement about prize delivery and interview.
- 6. **Interview Process:** The interview with the winner will be conducted by the local regional manager.
- 7. **Refusal to Participate:** If the winner refuses to participate in the interview, their win will be cancelled, and a new winner will be drawn in that region.
